



FOREST STOCK






Growing stock volume per hectare (left) and volume (right) on forest Source: State of Europe's Forest 2011.

Carbon stock on forest biomass (abouve ground and below ground) in million metric tones. Source: State of Europe's Forest 2011.






Annual increment of growing stock (1935–2009) and annual drain in Finland (1950–2009). Source: Finnish Forest Research Institute






WOOD IS AN IMPORTANT ENERGY SOURCE

Total energy production from wood as percent of the total national primary energy consumption.







Ownership of forest in Europe, 2010. Source: State of Europe's Forest 2011.


FOREST SECTOR'S CONTRIBUTION TO GDP

Oslo Ministerial Conference



- Ministerial Conference on the Protection of Forests in Europe, 14 to 16 June 2011, Oslo Norway.
- Conference hosted by the Norwegian government and coorganized with the Spanish government.
- The ministers responsible for forests adopted two important decisions:
 - Oslo Ministerial Decision: European Forests 2020, setting targets for protection and sustainable management of forests;
 - Oslo Ministerial Mandate for Negotiating a Legally Binding
 Agreement on Forests in Europe.

VISION FOR FORESTS IN EUROPE



 To shape a future where all European forests are vital, productive and multifunctional. Where forests contribute effectively to sustainable development, through ensuring human well-being, a healthy environment and economic development in Europe and across the globe. Where the forests' unique potential to support a green economy, livelihoods, climate change mitigation, biodiversity conservation, enhancing water quality and combating desertification is realised to the benefit of society;



Oslo Ministerial Mandate for Negotiating an LBA on Forests in Europe



- The ministers decided to launch the negotiations in:
 - Establishing an Intergovernmental Negotiating Committee;
 - Adopting the Rules of Procedures;

process.

- Establishing the Bureau which consists of the Chair of the Committee and representatives of the following countries: Austria, Czech Republic, France, Norway, Poland, Russian Federation, Turkey and Ukraine, Spain as permanent observer;
- Nominating the **Chair**: Mr. Jan Heino (Finland);
- Requesting the FOREST EUROPE Liaison Unit and inviting UNECE, FAO, UNEP and EFI to service jointly the negotiating

Intergovernmental Negotiating Committee



- The INC is open to FOREST EUROPE Signatories (46).
- **Observer States, Agencies and Organisations**, incl. NGOs are invited to participate to the work of the INC.
- 2011-2013 timeline:
 - The INC will commence its work not later than **31 December 2011**,
 - with the goal to completing its work not later than **30 June 2013**, and
 - will present its results to an extraordinary FOREST EUROPE ministerial conference to be organized within six months after the conclusion of the negotiations, for its consideration and possible adoption and opening for signature.

- The Committee shall:
 - Base its work on existing FOREST EUROPE Resolutions and Declarations and relevant international commitments;
 - Take into account the Non-paper on a possible legally binding agreement on forests in Europe;
 - Develop a holistic legally binding framework agreement for forests.



- The Committee shall address *inter alia* the following possible subjects (examples from the mandate paper):
 - To ensure sustainable forest management and the long-term provision of a broad range of goods and forest ecosystem services;
 - To maintain and enhance **forest resources**, their health, vitality and resilience, and their adaptation to climate change;
 - To increase the resilience of forests to natural hazards and to protect forest against human-induced threats;
 - To enhance the contributions of forests to the mitigation of climate change;



- To maintain and enhance the protective and productive potential of European forests;
- To create and maintain enabling conditions for European forests to contribute to a green economy, employment and the development of rural and urban areas;
- To maintain and enhance the cultural and social functions of forests in Europe;
- To enhance participation and cooperation on forests at local, national, regional and global levels.



- The Committee shall consider:
 - The importance of flexibility, so that Parties can take decisions adjusted to their specific forest conditions and needs in the future;
 - Global discussions on possible improvement of international arrangements on forests;
 - The need to avoid unnecessary duplication with other international agreements;
 - The importance of securing the effective participation of stakeholders;
 - Agreement on common terms and definitions
 - The possibility of the agreement being brought under the United Nations umbrella;

- Bureau Meeting held 5-6 September 2011 in Joensuu, Finland
- First Session of the Negotating Committee will be arranged 21-25 November 2011 in Geneva, Switzerland
 - Oslo Ministerial Decision: European Forests 2020
 - Oslo Ministerial Mandate for Negotiating a Legally Binding Agreement on Forests in Europe
